### Parental Involvement Policy

#### **PART I. GENERAL EXPECTATIONS**

**Aristotle Preparatory Academy** agrees to implement the following statutory requirements:

### **PART II. DESCRIPTION OF HOW DISTRICT WILL IMPLEMENT REQUIRED DISTRICT WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS**

1. **Aristotle Preparatory Academy** will take the following actions to involve parents in the joint development of its local education agency parental involvement plan under section 1112 of the ESEA:

3.   - **The School Parent Committee will be representing the following stakeholders: economically disadvantaged, disabled, limited English proficiency, limited literacy, or any racial or ethnic minority background as applicable to the school's student population.**
  - **Utilize posters and newsletters to notify parents of meetings and important school events.**
6. The **Aristotle Preparatory Academy** will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
